## 3a Insights and Context (750 words)

#### Guidance

Under this functional area there are three components:

- > Risk management principles and practice
- > The organisational environment
- > The external environment

In this section we are looking for you to demonstrate that you understand the principles and practice of risk management and the relevance and use of theories, processes and tools, and that you have used your knowledge of internal and external influences to ensure robust risk management is in place. Your submission should cover two of the three components.

Examples of areas where you can demonstrate your experience include:

- > embedding risk management practices into operational processes and/or organisational strategies.
- > horizon scanning for changes in the macro-economic, social, political, regulatory and competitive environments.
- identifying opportunities within the external environment to maximise reward and minimise risk.
- > evaluating the impact of material change programs.
- > benchmarking the relevant strengths of aspects of the risk management framework.
- > new product or service evaluation.
- > influencing management decision making.

Your answer should be limited to the space provided and not exceed 750 words.

## 3b Strategy and performance (750 words)

#### Guidance

Under this functional area there are four components:

- > Risk management strategy and architecture
- > Risk management policy and procedures
- > Risk culture and appetite
- > Risk performance and reporting

In this section we are looking for you to demonstrate that you have appropriate experience of developing, or helping to develop, appropriate risk management strategies, policies, guidelines, procedures or action plans which meet organisational needs and reflect the organisation's risk appetite. Your submission should cover **two** of the **four** components.

Examples of areas where you can demonstrate your experience include:

- > developing, implementing and promulgating a relevant risk management framework including appropriate policies and procedures. Training and raising awareness is a key element of this component.
- > implementing risk management policy; assigning risk ownership throughout the organisation and putting in place appropriate levels of responsibility, delegated authority, and accountability to ensure effective risk management.
- > developing and maintaining risk registers which describe probability, impact and mitigation.
- > contributing to the development, or in part, of the organisation's risk appetite statement and its cascading throughout the organisation.
- > effective reporting of risk management performance that either provides assurance to, or motivates change in, management.
- > assessment of the performance of risk management processes; using appropriate analytical tools to monitor changes.

Your answer should be limited to the space provided and not exceed 750 words.

Under this functional area there are two components:

- > Risk assessment
- > Risk treatment

In this section we are looking for you to demonstrate that you have appropriate experience of managing the risk management process for a material operational unit, process or change programme. At the operational level this includes:

- > identifying, assessing and prioritising risks.
- > assessing their likely probability and impact.

<ul> <li>developing and implementing or advising on appropriate risk mitigation including internal controls.</li> <li>determining whether the overall system of risk management is effective over time.</li> <li>contributing to, and the testing of, business continuity planning and crisis management plans (if appropriate).</li> </ul>

Under this functional area there are three components:

- > Communication and consultation
- > Change management
- > People management

In this section we are looking for you to demonstrate that you have appropriate experience of functional management. This includes, for example:

- > understanding and shaping the risk function's role within the organisation.
- > functional design.
- > recruitment, development and retention of a risk team with the right skills and positive attitude.
- > putting in place effective communication and consultation channels with stakeholders.
- > involvement in continuous improvement regimes and/or objective, independent third party reviews of quality.
- > implementing change plans in a way that minimises disruption to operations.

Your submission should cover two of the three components.
